



## **GOVERNOR GWENDOLYN GARCIA**

Governor Gwendolyn F. Garcia made history by being the first woman governor of the 441-year-old Province of Cebu.

After giving Cebuanos a dose of her service and leadership from 2004-2007, Gwendolyn Garcia got a much stronger approval from her people when she won by a historic half a million votes in her second term. And at the May 10 elections, Gov. Garcia achieved a political three-peat, as she triumphed for the third time in the gubernatorial vote and received a fresh mandate with another solid margin.

She has driven Cebu to international recognition, reinvented government by professionalizing the delivery of public services, and with her sharp eye for economic enterprise, she has led the province to unprecedented growth. With over P26 billion in assets, Cebu is the undisputed richest province in the Philippines.

Gov. Garcia aggressively pursues a 12-point agenda for her administration, implementing economically viable development programs that effectively respond to the needs of the Cebuano constituency – in infrastructure, water, power, health, education, agriculture and food production, women, business, tourism and the environment.

With sustainable tourism a priority, Cebu is now a premier tourism destination in the country and the region, taking pride in its rich culture and heritage, its beautiful coastline and spectacular beach resorts, and its world-class products.

She has declared an all out war against communist insurgency that has made Cebu an insurgency-free zone.

Gov. Garcia leads the Metro Cebu Development Coordination Board and is also Chairman of Mactan Cebu Bridge Management Council. She was the former head of the Regional Development Council Committee and the Regional Peace and Order Council.

She has recently been chosen as the new head of the East Asia Inter-Regional Tourism Forum (EATOF), a tourism cooperation network of 12 member provinces in East Asia which aims to promote and develop East Asia tourism in the world market.

A consistent honor student in her elementary and secondary years in St. Theresa's College in Cebu, Gwendolyn graduated with a degree on AB Communications from the University of the Philippines in Diliman, Quezon City. She proceeded to the UP College of Law, but eventually left to help her father who was then in his last term as Governor of Cebu.

She was conferred the Doctor of Humanities Honoris Causa by the Cebu Normal University and the Cebu Technological University.
